BACKGROUND

- During COVID, a large proportion of our division families enrolled their children in the division's E-Learning program that was implemented in response to growing demand.
- In March 2022, Holy Spirit School Division changed the name of the newly combined Trinity Learning Centre and E Learning School to be called the Trinity E-Learning School.
- 3. Post-COVID, enrolment in the E-Learning program has dropped significantly and is no longer a viable or fiscally sound option for the division. Therefore, it is proposed that the name of the school revert back to Trinity Learning Centre for clarity purposes.

RECOMMENDATIONS

That the Board of Trustees approves the change of name, from Trinity E-Learning School back to its original name of Trinity Learning Centre.

ByLaw No. 2024/01 OF THE

Holy Spirit Roman Catholic Separate School Division (the "School Division")

A By-Law of the School Division in the Province of Alberta, relating to the arrangement of the electoral wards and trustee(s) to be elected to each ward.

Whereas Section 76 (1) of the *Education Act* of Alberta provides that the Board of Trustees of the School Division (the "Board") may by bylaw provide for the nomination and election of trustees by wards and determine the boundaries of the wards, or provide for the election of trustees by the general vote of the electors.

Whereas Section 76 (2) of the *Education Act* of Alberta provides that the Board shall provide a copy of a bylaw passed under this section to the Minister after the bylaw is passed and before December 31 in the year prior to an election year.

Whereas Section 78 of the *Education Act* provides the Minister shall specify for each board the number of trustees, being no fewer than 3, to be elected to the board. The Minister may vary the number of trustees to be elected for each school division. The Board of Trustees of The Holy Spirit Roman Catholic Separate School Division hereby enacts as follows:

- 1. The number of trustees to be elected for each ward is as follows:
 - Ward No. 1 (Coaldale, Broxburn, Fairview, Tempest, and Area): One (1) trustee
 - Ward No. 2 (Lethbridge, Coalhurst, Craddock, Raymond, Stirling, and Area): Five (5) trustees at large
 - Ward No. 3 (Picture Butte, Diamond City, Iron Springs, Shaughnessy, Turin, and Area): One (1) trustee
 - Ward No. 4 (Pincher Creek, Drywood, Summer View, Twin Butte, and Area): One (1) trustee
 - Ward No. 5: (Taber, Bow Island, Barnwell, Chin, Cranford, Conrad, Elcan, Fincastle, Purple Springs, Reliance, Wrentham, and Area): One (1) trustee
- 2. In accordance with Section 2 of the *Local Authorities Election Act*, the Board of Trustees authorizes entering into agreements to hold joint elections in conjunction with the City of Lethbridge, and the towns of Bow Island, Coaldale, Picture Butte, Pincher Creek and Taber.

As set out in Section 76(2.b) of the *Education Act*, this bylaw does not apply to or affect the composition of the board until the date of the next general election to which the bylaw applies.

Triple M Housing report on addressing housing shortage

Triple M Housing's strategic shift to tackle the housing crisis in urban areas. Highlighted the company's collaboration with various government levels to integrate modular housing into Canada's housing strategy, including the completion of Alberta's first multi-unit multi-level modular project. Not for profit sector discussed potential federal funding for encampments.

Water situation in Old Man

Report on the improved water situation in the Old Man watershed, water sharing measures were activated, leading to reduced usage and more water in the reservoirs compared to the previous year. Also spoke about the ongoing efforts to fix the Milk River siphon pipe, which is expected to be completed ahead of schedule.

Discussion Impact of Drought on Cattle Industry

Insights into the significant impact of drought on the cattle industry, emphasizing the shortage of cattle and the struggles faced by farmers due to the lack of water and grass. Also discussed the decrease in feedlot placement and its potential implications for grain production. Cattle prices are up.

Allison and I spoke about the Premier's announcement and the implications of the Premier's address on the education sector and the potential impact on the local community. We invited feedback from attendees.

1. Attached for Board information is correspondence sent out to Holy Spirit Catholic School Division families from Minister Nicolaides, Minister of Education, welcoming Alberta students back to the classroom.



September 5, 2024

Dear parents,

As the summer winds down and a new school year begins, I want to take a moment to share updates you may hear more about as your child returns to the classroom.

As Alberta's Minister of Education, my mandate is to ensure our students are receiving a world-class education that sets them up for success. An important piece of this work is building an inclusive and comprehensive curriculum that reflects our modern world and inspires a passion for learning.

Since the 2022-23 school year, school authorities have implemented new curriculum in six Kindergarten to Grade 6 (K-6) subjects through a phased approach. This school year, all students in Grades 4-6 will be learning from new French first language and literature, French immersion language arts and literature and science curriculums. We continue to support school authorities and elementary teachers as they implement new curriculum by providing a variety of learning and teaching resources.

I am pleased to share that 62 school authorities have also chosen to pilot new draft K-6 social studies curriculum in classrooms across Alberta this school year. The new draft curriculum, which was developed after nine months of consultation with education partners, teachers, parents and Albertans, focuses on building students' critical thinking skills and empowers them to be engaged citizens. Throughout the piloting process, school authorities and teachers will provide valuable feedback to help Alberta Education finalize the new K-6 social studies curriculum.

This is just one change parents can expect in Alberta's schools this fall. When students return to class, their smart phones will not. In April 2024, we asked Albertans to tell us what they thought of cellphone use in schools. More than 68,000 educators, parents, and other stakeholders shared their thoughts. The feedback was clear: Almost 90 per cent of respondents were concerned about student cellphone use at school and 85 per cent said they believe cellphones have a negative impact on student achievement.

My government felt it was important to respond quickly to this feedback and has been working with educators and other stakeholders over the last several months to introduce restrictions on personal mobile devices and social media use in schools.

These changes come into effect on September 1, with school authorities having until January 1, 2025, to formalize their policies and procedures for implementing the restrictions within their schools. This means that, beginning immediately, students are asked to keep their devices silent or powered off during class and stored out of view, unless a valid exception is in place. Parents and guardians should reach out to their school or school authority if they have questions regarding how restrictions will apply to a particular student or child.

Restricting personal mobile devices and social media use in Alberta Early Childhood Services and kindergarten to Grade 12 classrooms will reduce distractions, maximize learning time, support student mental health, and reduce opportunities for cyberbullying. This is one of many things we are doing to support our children's mental health.

I recently announced an additional \$6.7 million to extend 59 Mental Health in Schools pilot projects across the province to ensure students can get the supports they need, when they need them. This is in addition to the Budget 2024 investment of \$1.5 billion for learning support funding, which includes funding that allows school authorities to provide students with psychological and social-emotional supports, and access to mental health workers and other wellness supports, as needed.

As you know, Alberta's population is growing, and school enrolment is too. Our government recognizes this growth comes with challenges, which is why we made a funding commitment over the summer to invest an additional \$125 million for operational costs associated with enrolment growth and inflationary pressures.

And, we have invested \$2.8 billion over three years to maintain, enhance, plan, and build new schools. Our capital plan advances 43 priority school projects across Alberta, including 28 new schools, 10 replacement schools, and five modernizations, which will create 35,000 new and modernized student spaces! We recognize these advancements will not be realized immediately and space is needed now, which is why we are also putting \$90 million toward the purchase of up to 100 modular classrooms and the relocation of up to 50 more, for the communities of greatest need. This will help address emergent enrolment pressures and urgent space needs.

In closing, I want to thank and acknowledge our hardworking teachers, educational assistants, principals, and other school support staff. Their work is at the heart of Alberta's education system and is deeply acknowledged and appreciated by Alberta's government.

Finally, I want to thank you, Alberta's parents. As a father myself, I know that a child's education does not start and end in the classroom. Parents are busy behind the scenes packing lunches and schoolbags, helping with homework, and cheering our kids on at their school concerts and sporting events. Thank you for all you do to support your children, their teachers, and the larger school community to which you belong.

Dear Minister Nicolaides,

It is with great pleasure as Chair of the Board of Trustees for Holy Spirit Catholic School Division I write this letter regarding a significant initiative that aligns with both the priorities of the Alberta Government and the goals of our school division. As a Board we firmly believe each student who graduates from our schools should have the opportunity to pursue what is meaningful to them, will bring value to our society, become active citizens of our province and country, and be faithful witnesses to their Christian faith. With this letter I want to highlight the important career preparation work being done at Catholic Central High School in Lethbridge through their successful implementation of a Trades Foundations program.

I would like to recognize several key factors contributing to this important endeavor and its success:

- 1. The Quarter System Timetable: Prior to the turn of the century Catholic Central High School adopted a four-semester school year. Each semester is ten weeks long with students taking one class in the morning and one in the afternoon. The benefits of this immersive style of teaching and learning are numerous. First, the three-hour time block provides students with meaningful opportunities to pursue a work experience that actually exposes them to the real-life experiences. The second, addresses the extended time related to the needs of the Careers and Technology Studies (CTS) programming. The CTS program at this school is varied and very much in keeping with teaching essential knowledge and skills associated with the variety of jobs attached to each strand. The extended time allows time for students to engage deeply with hands-on projects and gain substantial industry experience. They have the time to explore, learn, build, adapt, and re-build without the limitations of a traditional semester system.
- 2. Provincial Grant and Community Involvement: A couple of years ago the school division applied for and received a grant to help with the modification of a CTS shop to better suit the needs of the program. The grant allowed for the installation of an industrial garage door as well as the acquisition of some specialized equipment. These improvements, complemented by additional funding from our Infrastructure Maintenance and Renewal (IMR) funds, have significantly enhanced the program's capacity. With the commitment of local businesses, our students are exposed to a variety and diversity of trades. To that end, the following companies donated time, talent, and treasure to our new Trades Foundations program: Southland Trailer Corp., Eecol Electric, Borne Industries, Southland International, Banditos Incorporated, Lethbridge College, Bartle & Gibson, Wolseley, CDX Learning Systems, Mikado Electric, CEP Automotive Ltd., TNT Towing, Canadian Tire South, Snap-On Tools, The Bolt Supply House, Princess Auto, and Logic Lumber. .../2

3. Dedicated Personnel: We are very fortunate to have hired a highly motivated and energetic teacher who took it upon himself to become a journeyman welder so he could teach the full scope of the CTS strands associated with welding. He took this experience and built a Trades Foundation program where students would gain handson exposure to numerous trades. Mr. Lance Rosen, alongside his teaching colleague, Mr. Brett Skauge are to be applauded and acknowledged for putting into place a program that truly meets the career objectives of the province and the school division and delivering valuable learning outcomes for our students.

The Trades Foundations program just completed its first full year of implementation. Each quarter roughly 30 students gained first hand exposure to: Mechanics, Construction, Electrical, Plumbing, and in the future HVAC, Drywall/Finishing, and Tilework. In addition, approximately 55 students from Catholic Central High School were able to work alongside their dedicated teachers assisted in each trade area by a volunteer Red Seal Journeyperson from local industry including Southland Trailer Corp., Southland International, Ward Brothers Construction, Top Notch Mechanical, and a Journeyperson from the Maintenance Department at our school division to grow in their knowledge and experience of these trades. Further to the in-house programming, the program also boasted various on-site interactive tours of our industry partners' facilities including Southland Trailer Corp., Lethbridge College Trades Wing, CEP Automotive Ltd., Southland International and Bourne Industries which allowed students to see the skills they are learning in class being applied in real-world industry scenarios.

In closing, I want to thank you and your government for the foundational funding that allowed this growing program to bloom; acknowledge and thank the businesses and their employees for stepping up and making such a wonderful contribution to careers education; and to honour the wonderful work done by the teachers and administration at Catholic Central High School turning provincial and school division aspirations for students into reality. It is indeed heartwarming to witness the powerful impact provincial leadership, school commitment, and industry support can have on education.

All students demonstrate growth in literacy & numeracy.

Year-end data for the CC3 & Alberta Numeracy Assessments was released in July. Below is the comparison data from our Beginning and Year-End results. There was a marked decrease in the number of 'at risk' students in all of the year-end assessments which can be attributed to the responsive targeted interventions provided by our teachers and support staff.

Board Strategic Priority - Strengthening Our Catholic Faith

We foster a Catholic worldview of reflection, service and sacramentality.

- Proclaim! Pilgrims of Hope Our focus this year is on having God on our lips, reflecting on the Creed and kerygma, and boldly sharing our faith with the world around us. Underpinning all of this is our key scriptural reference, from 1 Peter 2: 9 "you are a chosen race, a royal priesthood, a holy nation, God's own people, in order that you may proclaim the mighty acts of him who called you out of darkness into his marvelous light." We have created a number of tools to support staff in implementation of the plan including: Catholic School Identity Inventories, a Monthly Journal, and Conversation Slides.

We will assist students in navigating various pathways of support.

Ready, Set, Go Fair - The "Ready, Set, Go" Fair, held on August 21st and 22nd, was a
tremendous success, supporting over 1,600 students with essential school supplies and
backpacks. This initiative was made possible through a partnership involving our
divisional team, Lethbridge School Division, Lethbridge Food Bank, Inter-Faith Food
Bank, and My City Care. Additionally, divisional donations have been set aside to assist
several of our rural schools, ensuring families in need receive the necessary supplies for
the upcoming school year.

We provide programming and support for student and staff well-being.

- Nutrition Program We are thankful for the continuation of the Alberta Education

First Nations, Métis and Inuit Education Report to the Board of Trustees September 2024

Board Strategic Priority: Living Truth and Reconciliation

Our First Nations, Métis and Inuit students will continue to see increasing success rates.

• Jordan's Principle Updates - We have completed our reporting on the 2023-2024 school year and have hired almost all of our positions under our Jordan's Principle funding. The earlier approval from Jordan's Principle has allowed us to operationalize this funding much more quickly this year. We are presently updating our data sets and tracking forms for this year.

We foster reconciliation through listening, accompaniment and recognition of the ongoing impacts of the past.

- Week of Truth and Reconciliation The focus of this year's resources (distributed via email and poster) is encouraging exploration, understanding, and respectful integration of these themes. Throughout the year, our newsletter will delve more deeply into topics such as fostering respectful communication, cultural appreciation and appropriation, and braiding indigenous spirituality and Catholic values. This fall, as advertised in our communication, we will be offering a staff book study of Truth Telling, by Michelle Good. Registration will be available during the week of Truth and Reconciliation.
